APPLICATIONS

DIRECTIONS

Remove towelette and unfold fully. For maximum protection, wipe evenly and completely over all exposed skin. Do not apply near eyes and mouth, and apply sparingly around ears. Each towelette will cover the face and arms or an equivalent size area. Apply only to exposed skin, do not use under clothing. Never apply over cuts, wounds, or irritated skin. Do not allow children to handle this product, and do not apply to children's hands. When using on children, apply repellent to your own hands first and then apply it to the child. Avoid overexposure; frequent reapplication and saturation are unnecessary. Use just enough repellent to cover exposed skin. Wash hands after treatment to avoid incidental contact. After returning indoors, wash treated skin with soap and water or bathe. Remove and wash treated clothing before wearing it again. Do not apply on or near: acetate, rayon, spandex or other synthetics other than nylon, furniture plastics, leather, watch crystals and painted or varnished surfaces including automobiles.
